## DOG ADOPTION CONTRACT

A dog adoption contract concluded on ..... in Gorzyce

### BY AND BETWEEN

Gorzyce Association "Animal Corner" [Gorzyckie Stowarzyszenie Zwierzęcy Zakątek]

providing a dog for adoption free of charge, hereinafter referred **to as Original Caregiver**

### §1

The contract concerns the adoption of a dog with a temporary name .....

### §2

1. The Adopter undertakes to take proper care of the adopted dog, providing it with food (in accordance with the instructions of the Original Caregiver), conditions for a healthy life, safety, including proper securing of the place and area where it is staying, protecting against escape, accidental exit, biting, theft, etc., as well as compulsory vaccinations and treatment.
2. The Adopter acknowledges that mistreatment of an animal may result in criminal liability under the Animal Protection Act of 21.08.1997 (as amended).

### §3

The Adopter determines the whereabouts of the animal ..... and undertakes to notify in writing within 7 days of any change in the animal's address. It does not apply to occasional and short trips.

### §4

1. The Association has the right to carry out announced and unannounced inspections at the animal's place of stay, during which the Adopter must show the animal and the health record book for inspection.
2. The Adopter undertakes to enable control of persons representing the Association.
3. In the event of inadequate conditions, the Association has the right to take back the animal from the Adopter, who undertakes, in such a case, to immediately hand over the animal.
4. The determination and assessment of the conditions under which the dog is kept shall be made exclusively by persons representing the Association.

#### §5

1. The Adopter undertakes not to get rid of, sell, abandon or give up the dog to third parties.
2. The Adopter shall undertake the following obligations:
  - the treatment of the animal according to the instructions provided upon reception,
  - annual vaccination against rabies and other diseases with a general health check-up by a veterinarian with an entry in the booklet (information on treatments provided electronically to the Association),
  - not letting the dog out in open spaces without supervision,
  - fulfillment of all obligations under local law.
3. Animals shall not be put in pens, basements, boiler rooms or on a chain.
  - a sheltered-insulated kennel, available to the animal only when the owners are away.
4. At the time of the adoption, the Adopter is obliged to have: anti-leakage harness, extended leash, min. 5 m, a collar with the dog tag, food indicated by the Association.

#### §6

If the animal has not been sterilized or neutered, the Adopter must have this procedure performed by a veterinarian by the date indicated on the adoption date ..... **The Adopter is obliged to confirm the performed surgery with written information from the veterinarian performing the surgery and to deliver it in a convenient way to the Association's representatives, e.g. by post, e-mail, in person.**

#### §7

The Adopter declares that he is aware of the dog's condition, has familiarised himself with it and has no claims on it.

#### §8

1. In the event of a change in living conditions and inability to continue caring for the animal, the Adopter will immediately notify the Association's representatives.
2. In the event of a serious illness of the animal, accident or death, the Adopter undertakes to immediately notify the representatives of the Association providing details within 7 days.

#### §9

1. The Adopter undertakes to provide information about the adopted animal for the first month every week and as needed, then quarterly, and at least every six months, sending information and photos to the **Facebook group Adopciaki Zwierzęcy Zakątek** [/www.facebook.com/groups/872300503529566](http://www.facebook.com/groups/872300503529566)
2. The Adopter agrees to the processing of his personal data necessary for the performance of the contract, in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46 / EC

(General Data Protection Regulation) Journal of Laws. EU. L. L. of 2016, No. 119) - hereinafter referred to as GDPR.

### **§10**

In the event of failure to comply with any of the terms of the adoption Contract, the dog shall return into the ownership of the Association without further declaration of intent and the Adopter undertakes to surrender the dog to the Association without delay.

### **§11**

Whenever the Contract refers to representative persons, it refers to persons who own a written authorization or are listed in the authorities of the Association.

### **§12**

Any disputes shall be submitted to the competent court for the seat of the Association.

### **§14**

The Contract has been drawn up in two counterparts, one for each party.

### **§15**

Any amendment to this agreement must be made in writing.
